# **BOARD OF TRUSTEES MEETING - MINUTES**

Thursday, November 9, 2023

President Fran Lloyd called the meeting of the Whitehall Township Public Library Board of Trustees to order at 6:33 p.m. in the library.

#### MINUTES OF THE PREVIOUS MEETINGS:

Motion to accept October 12, 2023 minutes by Tom Ernst. Kathy Betz seconded and the motion carried.

#### LIBRARY DIRECTOR'S REPORT:

- State and District Libraries:
  - o Susan Bielucke submitted WTPL's Plan for State Aid on November 7, in advance of the December 1 due date. The Plan is a requirement to receive state aid.
- Financial:
  - o Grants:
    - Susan has applied for the Iron Pigs Grant to support a "Let's Move in Libraries" program at WTPL. Requested funds would be used for Yoga Story Time, Teen Zumba, Adult nutrition/wellness programming and birding backpacks. Grantees will be notified of award status on December 9.
    - Susan is working toward completing the Trexler Grant application by the December 1 due date.
  - o Fundraising:
    - The Basket Raffle continues through November 11. As of November 2, WTPL netted \$1,350 during presale. This year's goal is \$3,000.
    - The Boscovs Friends Helping Friends fundraiser netted \$120.
    - The fall fundraising was mailed out during the past two weeks.
    - The Spring Book Sale is scheduled for April 26 and 27.
  - o Employee Retention Tax Credits:
    - After researching various options and subsequent discussion with WTPL's Board,
       Susan has chosen First Nonprofit to submit the application for tax credits.
- Personnel:
  - o The Staff Christmas Party will take place at the library December 8 at 4:00 p.m. Staff members will participate in games and an optional gift exchange.
- Outreach/Collaboration:
  - o The library will begin collecting for the Toys for Tots program on November 13.

o Susan met with Deb Rosene of the Whitehall Environmental Advisory Council regarding a partnership in providing Spring programming for children in 3rd - 6th grade and for adults. They are also working to provide Birdwatching Backpacks for check out by patrons. Whitehall EAC will provide maps, bird identification materials and possibly backpacks. Susan included funding for binoculars in the Iron Pigs grant request.

Ed Hozza made a motion to approve total October payments in the amount of \$26,717.88. Tom Ernst seconded and the motion carried.

## **COMMITTEE REPORTS/DISCUSSIONS:**

#### **BUILDING AND GROUNDS** (Joan, Tom):

- The Board discussed WCSD's proposed contribution toward WTPL building improvement Bid Package A. Kathy Betz made a motion to approve acceptance of WCSD's proposed contribution toward Bid Package A. Ed Hozza seconded, and the motion passed.
- Snow removal and grass cutting: WCSD would charge WTPL \$2,000 annually as
  opposed to an annual cost of \$3,500 to hire an outside contractor. WCSD's charge would
  include weeding and fall cleanup. These services and the associated charge would be
  included in WTPL's lease with WCSD. Tom Ernst made a motion to have WCSD provide
  snow removal and grass cutting services at an annual cost of \$2,000. Kathy Betz
  seconded the motion and the motion passed.
- The Board learned that Bethlehem Area School District will pay the insurance deductible toward repair of the damaged parking lot light pole.
